Dear Senator Cornyn:

As Texas employers and U.S. patent holders, we are writing to express our concerns about the Patent Reform Act (S. 1145) under consideration in the Senate. While we support efforts to update and improve our patent system, we are concerned that the legislation as reported out of the Judiciary Committee would minimize penalties for infringers, undermine the rights of patent holders, and hamper innovation.

Since the legislation was first contemplated, activities proceeding independently on multiple fronts have curtailed the rights of patent holders. A number of landmark decisions at the Supreme Court and Federal Circuit have addressed several key elements of patent reform. Recent regulations announced by the USPTO would limit the number of continuations and claims in patent cases. Certain provisions in the Committee bill would negatively compound the cumulative impact of these judicial and regulatory changes on patent holders.

Economic growth depends upon the continued strength and reliability of the U.S. patent system, which has recognized and protected the rights of inventors for more than two centuries. It is alarming that a number of diverse industries such as venture capital, biotechnology, nanotechnology, and manufacturing have registered concerns with S. 1145 that have not been addressed.

The concerns center primarily around the proposed changes to the well-established principles used to calculate damage awards and several issues related to a costly new post-grant opposition system. Further, the bill's change to patent venue rules would distort the current system in favor of defendants, creating backlogs in districts with a concentration of patent-using industries. We also support stronger reforms than currently in the bill to the judicially-created doctrine of inequitable conduct that will enhance the overall quality of patents issued by the USPTO and reduce excessive litigation costs.

The unintended consequences of S. 1145 in its current form are potentially harmful to the economy of Texas and the nation. We are hopeful that this legislation will be amended to address these and other concerns prior to floor consideration. We look forward to working with you to ensure that patent reform legislation will improve patent quality without diminishing patent rights and the strength of the U.S. patent system.
